## PROJECT REQUIREMENTS

**Scope of Work:** To supply, as specified, all labor, materials and equipment as needed to provide and install one (approximately) thirty (30) foot double gate across driveway and move and reinstall one existing double gate at **Pre-K Center located at 206 Bradwell Street, Hinesville GA 31313.** Exhibit" B" indicates location of gates, both new and gate to be removed and reinstalled. Flagged stakes on the site will also be provided.

#### **Timeline:**

Bid deadline is 2:00 p.m. Thursday October 17, 2013. Contract award is expected to be within 5 days of receipt of bid.

**Bidder Qualifications:** Bidding Firms shall be firms regularly engaged in fence/gate installations with minimum 3 years experience. Provide 3 or more references on form provided.

Liberty County School System reserves the right to reject any and all bids and to waive technicalities and formalities.

#### License, Insurance Requirements:

Bidders must be fully licensed and insured for the type of work to be performed in the **State of Georgia/Liberty County** at the time of submittal of their bid.

Verification of insurance and license will be required before award of bid.

### **SPECIFICATIONS:**

**NOTE:** <u>New Gate</u> to be as described on EXHIBIT "C" or approved equal that is approved by owner before bid date.

**Quantities:** One (approximately) 30 foot industrial grade aluminum ornamental double drive through gate. All sizes to be verified by contractor.

One existing double gate to be removed and reinstalled at location indicated on drawing. **Color:** Black

**Pickets:** 4 inch spacing with spear tops similar to existing fence around playground. Wall thickness of pickets to be not less than .062

Height: 4 feet

**Gate Post**: to be 6 inch x 6 inch with not less than.250 wall thickness; hold open post to be not less than 2x2 inch with .125 wall thickness.

**Post Tops:** to be ornamental tops to exclude moisture from post.

**Post Foundations** shall be not less than 2500 psi concrete; Concrete to be crowned at finish grade.

Post Foundation Size Requirements

Hardware/Fasteners: All fasteners and miscellaneous hardware to be aluminum or stainless steel.

**Gate Hinges** to be structurally capable of supporting the gate without binding when opened. Gate to open a full 180 degree.

**Gate Latch** shall have a drop rod arranged to engage the gate stop. The locking devise shall be constructed so that the center drop rod cannot be raised when the gate is locked and shall have a provision for a padlock. Gate is to be capable of being locker both open and closed.

**Move existing gate** and install at location indicated on drawing. Exercise care when removing gate, post and hardware to avoid damage. Provide touch-up painting, straightening and alignment of parts and hardware to provide acceptable fit and operation.

All materials in this specification to meet or exceed quality of gates manufactured by Elite Fence Products, Inc. Industrial/ Heavy Industrial grade or approved equal. If bidding a product other than referenced product, approval, as equal, by the owner will be required before bid date.

<u>Utility Location</u>: Every effort is to be made, before digging, to locate all underground utilities; coordinate location effort with owner.

# **SCHEDULING OF WORK:**

All scheduling shall be coordinated with the Owner. Provide bidders "estimated time to complete" with bid submittal.


